



## KAT CAMMACK: WHY DID YOU LIE ABOUT BEING HOMELESS? AND WHAT ELSE ARE YOU LYING ABOUT?

Dear Kat:

Voters love a rags-to-riches story. America is the land of opportunity and voters love to hear about candidates who lifted themselves out of poverty through hard work and perseverance. ## KAT CAMMACK: WHY DID YOU LIE ABOUT HOW YOU LOST YOUR PROPETRY? AND WHAT ELSE ARE YOU LYING ABOUT?

Dear Kat:

I am a true conservative. I believe in hard work, limited government, and taking responsibility for your actions. You are a not a conservative or a real Republican. You are a millennial who feels entitled to endless government handouts and you blame others for your mistakes. You are a fake, a fraud, and a liar.

On your website and in countless news outlets, you have repeated the lie that your family lost its cattle ranch because of an Obama-era government program. That is two falsehoods wrapped into one: your mother never had a cattle ranch, and your mother lost her property because she used the home like an ATM machine. Your mother took out 8 separate mortgages on the property from five separate banks. Here are the facts. When your mother bought a 33-acre piece of land in Castle Rock in 1993 for \$192,000, she paid \$68,000 as a down payment. She then proceeded to borrow against the property on 8 separate occasions:

Instead of responsibly paying down the principal and building equity in the property, your family used the property as a source of cash for personal spending. Your mother took out 8 separate mortgages on the property, and in the process pocketed \$312,000.



Your family lost the property – not because of an Obama-era program – but because of your own financial mismanagement and greed. Rather than demonstrate conservative values of hard work and saving, you and your mother acted irresponsibly and used the equity in your property to fund a lavish lifestyle. For example, in 2009, you spent \$30,000 so you can live on a luxury yacht for 108 days in a program called “[Semester At Sea.](#)”

Your mother stopped making payments on the property in April 2010. When the mortgage company started foreclosure proceedings, your family sought a handout from an Obama-era program meant to bail out irresponsible Leftists. ## **Kat Cammack: Why Did You Lie About Being Raised on a Cattle Ranch? And What Else Are You Lying About?**

Dear Kat:

On your website and in countless news outlets, you have repeated the lie that you were raised on a cattle ranch. This is patently false. Your family did not operate a cattle ranch and you never worked on a cattle ranch for a day in your life. The voters want to know: why did you lie about your background? And what else are you lying about?

Let us start with the facts. In 1993, your mother (Virginia Mary Cammack) bought a 33-acre piece of land located at 5265 Garton Road in Castle Rock, Colorado for \$192,000. This inexpensive piece of land was far too small for a cattle ranch. Even a “small” cattle ranch is typically over two hundred acres. Tax records from this property show that the land did not have any improvements on it, which means there were no barns or other facilities required to operate a cattle ranch.

We contacted the local Colorado chapters of the Cattleman Beef Association and the Future Farmers of America and neither group ever heard of your family or your ranch. Lying is morally and ethically equivalent to theft. When you lie to your constituents, you are literally stealing the truth from them and replacing it with a falsehood. It is far worse than being held up at gunpoint. When a person holding a gun robs you, at least they know a theft has just occurred. But when your constituents trust you to tell the truth – and you tell lies instead



– you are taking advantage of their trust and leaving your constituents defenseless.

When I worked on Wall Street, I exposed fifty-two companies who were committing fraud on their shareholders. If you know my work, you know I break things down to get at the facts, factors, and circumstances that matter to the learn the truth. Now I am coming for you.
