



OPEN LETTER ON PROTOCOL FOR MEETING OF MANUEL P. ASENSIO AND KAT CAMMACK

January 24, 2021

Dear Kat:

I have confirmed my attendance as a candidate for the endorsement of the Executive Committee of the Republican Party of Clay County at tonight's meeting to be held at 7:30 p.m., at the Town Hall of Orange Park 2042 Park Ave Orange Park FL 32073 on Monday, January 24th, 2022.

It is important that we discuss the diplomatic formalities and etiquette for our first meeting. I want today's meeting to create a clear public record the differences between my plan to restore the constitutionality of the 2020 Presidential Election and domestic relations in America, and yours.

Domestic relations include the right of parents to pass down to their children their religious and *political* beliefs especially in the areas of the 1619 Project and WOKE culture.
