



OPEN LETTER TO THE HON. JUDGE MONICA BRASINGTON

July 8, 2022

Dear Hon. Judge Honorable Judge Monica Brasington,

The Florida Department of State and the Florida Division of Elections have qualified me as a member of the Republican Party and placed me on the ballot as a candidate in the Republican Party's primary election of 2022. I registered to vote as a member of the Republican Party in 1973 in the State of Florida and have never asked to be unregistered or to change my political party affiliation.

I, my mother, Caridad Asensio, the Founder of the Caridad Health Clinic, and a member of the Florida's Women's Hall of Fame and a recipient of the US President's Jefferson Award Medal for American Public Service, and my father, and my aunt and uncle who adopted me in order to be able to take me with them out of Cuba on May 15, 1961, which was two weeks after the Bay of Pigs Fiasco, and my sister, Alina Asensio, are lifetime anti-Communist conservative registered members of Florida's Republican Party. Caridad and my father decided to have me taken out of Cuba to save me from Communist indoctrination, which Caridad noticed had already begun at my school.

OPEN LETTER TO FORMER FLORIDA US CONGRESSMAN TED YOHO CONCERNING THE STATE OF THE REPUBLICAN PARTY IN ALACHUA COUNTY

July 7, 2022

Dear Honorable Ted,

The truth is that these are the worst of times for America. The radical Left is indoctrinating our children to believe that America was founded in 1619 to protect slavery and not in 1776 to protect God-given natural rights, individual liberty, and freedom from government; that the Founding Fathers were white supremacist; that women have a constitutional right to kill babies on demand; that sex is a social construct and not biological; that borders are racist; that guns not evil people commit murder; that everything is relative; that there are no definitive rights or wrongs; that there is no God; and that religious worship is an expression of superstition. The worst thing the Left is instructing our children is that government is all-knowing and good; that even unlimited government systems, like socialism, Marxism, and communism, are benevolent; and that free enterprise and capitalism are malicious. A generation of children has grown up believing that government has the right to lie to us about the real inflation rate, to use this lie to print money to manipulate our GNP up and the money Americans earn on their US dollar bank deposits down, and to avoid telling Americans the truth about the budget and trade deficits and how and how much the federal government is taxing them.

There are also truths that you and I know and that I have a duty to share with voters in my open letters. These are truths about Kat Cammack's policies and my policies to address these issues. My Republican opponents are trying to use the courts take me off the ballot to protect Kat Cammack. Therefore, I must write you to expose the truth not included in the attached the legal memorandum but truths that you and I know.

These truths start with the fact that it is Kat Cammack who is the only real beneficiary in Justin Waters' lawsuit and that Justin Waters is a front for Kat Cammack to attack me. Kat Cammack and I are political rivals who are both seeking the Republican nomination for the office of US Representative for Florida's 3rd congressional district. Ms. Cammack is using Waters to protect herself from scrutiny within the Republican Party in Alachua County, in Florida's 3rd congressional district, and in the press. Waters is Ms. Cammack's political ally whose function is to protect her from my questioning and my demand that she fulfill her democratic obligation and constitutional duty to speak with me in the public square and to debate with me on my policies in the media.

There are other truths relevant to the timing and origins of the lawsuit. Alachua Republican Chair Ed Braddy and Kat Cammack have known about my decision to run for Congress since July 2020, shortly after your run in with AOC, and that Jeff Childers was the first Republican Party leader in third that I met after I moved into the district. We met within days of me arriving here to discuss



my interest in collaborating with him as my attorney on my campaign against Kat Cammack. My meeting with Mr. Childers focused on the two laws and my work with the members of the US Judicial Conference. I also met with Brian Graham and Stafford Jones, who are the two most influential political consultants in the Republican Party in North Central Florida. At the same time, my campaign and I had an extensive dialogue with Kevin McCarthy's agent to discuss the constitutional matters in Kat Cammack's issues and the role this plays in the federal government's current state of constitutional corruption.

Ed is working diligently to completely ostracize me in the Republican Party and to protect Kat Cammack, a candidate everyone knows is an opportunist with no plan to address the nation's problems and who will say and do anything to help herself. Just last week, Ed refused to allow me to speak to a gathering of leaders of Alachua's Republican Party. I deferred to Ed ONLY because you and your lovely bride were present, and it was a celebration of your outstanding political career.

All this goes to show the political nonsense and legal absurdity of claiming that there is some sort of emergency within the Republican Party that requires my removal from the ballot. In fact, Kat Cammack has been claiming that I am not qualified to be on the ballot and using this story to create rumors of me being a spy for the Left since August 24, 2021.

This is not only political nonsense and legal absurdity, but it is an act of maliciousness and political collusion against democracy and our Constitution.

You say that the most important thing that voters need to know about a candidate is why he or she is running. You have intimate knowledge of my motivation and purpose in running for Congress and why I am running against Kat Cammack. It is time for you to speak out!
