## **TRUMP LAWYERS SABOTAGED HIS JUDICIAL CONDUCT ACT COMPLAINTS**

**Trump's Judicial Conduct Act complaints could have ended the Left's destruction of the Rule of Law and the Constitution**

**Asensio successfully intervened and saved Trump's case from Legal Saboteurs**

**ST. AUGUSTINE, FLORIDA — June 29, 2026** — Manuel P. Asensio, Republican candidate for Congress in Florida's Sixth Congressional District, has successfully intervened in the *America First Legal Foundation v. Chief Justice John G. Roberts* [Civil Action No. 1:25-cv-01232] and President Donald J. Trump's actions under the Judicial Conduct Act that were dismissed. *Constitutional Law governs lawyers and judges before anyone else!*<sup>1</sup>

Asensio is accusing David Warrington, Assistant and Counsel to Trump and Chief of the Office of White House Counsel, Boris Epshteyn, Trump's closest legal adviser, and Daniel Epstein who works with Boris on Trump's litigation, of sabotaging Trump's historic action.

These are not RINOs. These are MAGA saboteurs. Asensio saved Trump's action from MAGA's legal saboteurs.

In 2025, Trump became the first president to activate the Judicial Conduct Act of 1980. This should have been brought MAGA voters a historic victory against the left. Trump's action

should have been recognized as monumental as the President Thomas Jefferson's *Revolution of 1800 against the federal lawyers and federal judges*. It can still be.

Asensio has restored Trump's action. He is running for Congress in Florida's 6<sup>th</sup> Congressional District to inform Trump and get the political power he needs to reverse the sabotage.

Sabotage is a serious flat factual accusation. Asensio uses facts to prove his accusation. He openly shares all relevant facts, factors, and circumstances. Asensio's knowledge and understanding related to motive, duty, notice, and causation are formally before Roberts and publicly available.

Asensio is open to debate against any comers.

Asensio stated, "Trump's actions under the Judicial Conduct Act are historic. They should have marked America's victory against the lawless Left. They should have restored Constitutional Order to Americans. Trump's Judicial Conduct Act actions should have quieted and reversed the left's charges that Trump and MAGA voters are bigots who do not respect the Constitution, rule of law, elections, or democracy."

Asensio added, "Trump's action was sabotaged by his own lawyers who placed their personal interest above their duty to the Constitution, Trump, and MAGA political movement. They placed their first loyalty to Chief Justice Roberts who is the unitary executive leader of the federal judiciary above their loyalty to America."

Trump's actions are a carbon copy Asensio's landmark 2019 civil rights action against Roberts and his subsequent 2021 action against Roberts under the Judicial Conduct Act. Asensio's actions are based on original proprietary causes and investigations. They are live. Trump's Judicial Conduct Act cases were summarily dismissed.

Trump's lawyers had Asensio's information. They were advised of Asensio's deep structural constitutional charge. They were on notice that Roberts had been unable to dismiss my action. Yet they filed weak shallow charges.

"This is a historic sabotage," Asensio said. "They knew my strategy had worked. They knew that I had Roberts cornered like a rat. They concealed me and the deep constitutional implications of my action from Trump, misused my information, and lost. Trump needs to know what happened."

The Chairman of the Republican Party of Florida (RPOF), Evan Power, has been slandering Asensio and his single-handed success in saving the Judicial Conduct Act and in trapping Roberts in his own unconstitutional judicial-administrative web since he took office. Power

is a candidate for Congress while working as a lobbyist and political consultant and serving as chair of the RPOF at the same time.

Asensio adds, “Even before ascending to the chair of the RPOF, Power has been spreading misinformation about the Judicial Conduct Act and me. Power and Randy Fine, who the incumbent in District 6, have endorsed each other. They are refusing to debate me and are blocking me from getting the *Truth to Trump*.”

Asensio is running for Congress to get to Trump. Power and Fine are part of the same Republican structure controlled by the Federalist Society. Federalist in Congress and the federal bureaucracy are protecting the lawyering machinery that has destroyed the rule of law corrupted the Constitution and sabotaged Trump and the MAGA movement.

The RPOF has no right, no authority, no reason, to endorse the Federalist Society’s ideology. Power had no right to endorse Fine on behalf of RPOF.

Asensio stated, “My political win guarantees my win in court against the Left in America. I saved Trump’s action. Randy Fine did nothing. Fine is offering nothing. Ask yourself, why is Power working against me?”

Asensio is running for Congress in Florida’s 6<sup>th</sup> Congressional District to get the Truth to Trump so that together with my Republican voters we can reverse the loss.
